I have been busy in September and October carrying out my work as Deputy Leader of the European Parliamentary Labour Party, a Socialist Group Spokesperson and as your local London MEP.

After August recess, Labour MEPs were confronted with some high profile European developments.

These included the first infringement proceedings against an EU Member State on a human rights issue (France – the expulsion of the Roma). They also included action by MEPs on the banking crisis.

With this and other issues, we can see how the post-Lisbon European Parliament is proving to be an ever more important platform on the world stage for progressives to promote our shared politics.

France, the EU and the Roma

The French expulsions of Roma provoked international outrage.

The removals were illegal, immoral and ugly.

As S&D Group Spokesman on Civil Liberties, Justice and Home Affairs, I led the parliamentary pressure on the European Commission to act, speaking out widely in defence of the Roma in the international press. I highlighted the basic fact that EU citizens have the right to free movement in Europe.

I also led for the S&D at the hearing where infringement proceedings against France were announced.

Sarkozy is scapegoating the Roma at a time of historically low ratings for his presidency. The issue is that no EU Member State should be able to take such actions against EU citizens based on their ethnic background simply for political reasons. Our action in the European Parliament fired a warning shot at EU Member States who are already expelling EU citizens to Romania and Bulgaria including Sweden, Denmark and Italy.

Bankers' Bonuses – EU Action Tougher than Expected

I reported to you in June that a number of consumer-led initiatives are being taken by the European Parliament.

Among these, I highlighted the issue of bankers' bonuses. Now, in October, papers like the Financial Times have been reporting how the rules on bankers' bonuses will be tougher than expected by those in the industry.

The EU is now requiring that up to 60% of bonuses be deferred for up to five years as well as ensure that half of any bonus is paid in a way that is linked to a bank's performance, for example in shares.

This will prompt restructuring in many investment banks and is a concrete example of how Labour MEPs and the European Parliament are taking steps to ensure that the sort of structural problems we saw in the financial crisis are removed.

The EU Budget

Labour MEPs will amend and vote on the EU budget this week, at the same time as the CSR. We are very conscious of how the cuts will affect people in London, and as a group will vote against all measures which are deemed unnecessary or trivial at this difficult time. If necessary, Labour MEPs will vote against the EU budget.

In the budget, the Parliament wants to toughen budget rules to prevent sovereign debt crises. There are elements to the EU budget which Labour MEPs will focus on including the fact that the Tory-Liberal coalition opposes the European globalisation fund, which has helped EU redundancy pressures in the UK and will be necessary in the coming period of cuts.

The Labour approach to the EU budget is that we do not want to see dogma driven cuts which will endanger public services over and above what is absolutely necessary to reduce the deficit

Pakistan human rights and visa agreement

A new agreement between Pakistan and the EU obliges Pakistan to readmit nationals found to be living “illegally” in the EU.

On human rights grounds, I refused to back an imperfect agreement, which nevertheless passed on the basis of votes from centre right MEPs.

I will continue to keep a close eye on this issue and continue to represent the views of Londoners on international human rights.

Also in the European Parliament in September and October...

Commission President Barroso made the case for **drastic cuts in European public spending** in his State of the Union address. Labour MEPs countered the speech, making the point that deep cuts destroy jobs and ruin projects such as high speed rail and sustainable industries.

Violent anti-gay riots in Serbia could hurt the Balkan country's bid to join the bloc. The riots showed a lack of tolerance for minority rights in Serbia.

European institutions marked the eighth **World Day against the Death Penalty** on 10 October, reaffirming Europe's opposition to capital punishment worldwide.

The European Parliament today **voted by 390 to 192 the extension of maternity and paternity leave** across Europe. There was cross-party support for new mothers to have 20 weeks off work with full pay and fathers to have two weeks and the Parliament must now negotiate hard with EU ministers to make these improvements a reality.

Opposition Watch

UKIP abstain on vote condemning Iran stoning death sentence

The European Parliament's resolution condemning Iran for sentencing women to death by stoning was overwhelmingly supported by MEPs: not one MEP voted against. Yet UKIP MEPs abstained. Even their far-right Italian and Danish colleagues supported the motion. UKIP is unwavering in its commitment to oppose anything that the European Parliament endorses.

Conservatives oppose measures on discrimination against women

The Tories have voted against calls for better care provision for older women, against a recognition that gender discrimination does not disappear with age, and against "the right to adequate, affordable and quality social and health

services of general interest" for older women. They were joined by the racist Lega Nord from Italy and Andrew Brons from the BNP.

Both reports on anti-discrimination were adopted by overwhelming majorities of other MEPs.

BNP lose court case brought by Marmite

The legal action brought against BNP for misuse of the 'Marmite' brand finished with the BNP settling to Marmite's owners, Unilever, out of court.

Tory Leader Steps Down

This week, Timothy Kirkhope MEP stood down as leader of the Conservative MEPs. This may result in a further shift to the right for their group.

Labour Party News
